General: When dealing with an issue such as integration and an educational paradigm, in this case Ukraine joining the EU system/model, it would be interesting if, at least in the introduction, it was briefly informed which are these differences that need to be sought (in addition to those addressed as the focus of the article, in this case, the digitization and modernization, in technological terms, of Ukrainian education). At least a reference to some kind of document/text/website that can be consulted by readers to find out what the Ukrainian educational model is, what the European educational model is, would be an excellent addition to the proposed debate. It is important to think that multilingual and foreign publications do not share certain bases that may be common when we are writing in our own region or country, so some information that may seem trivial may be of great interest to international readers and it is up to the authors to provide the international reader with the widest possible access to the contents that are addressed in their works.
