Abstract: It is important that the abstract address all fields of the work, from a brief introduction

to the conclusions and discussions presented, as well as the methodology, in the case of this

text there is no mention of the methodology in the abstract, it is interesting that this mention is

made directly, always respecting the limit of 150 words.

Introduction: The introduction actually presents the themes that will be worked on throughout

the text, as well as bibliographical connections and their relevance, but it does not present the

work itself, it is relevant that the introduction contains a presentation of the objectives of the

work, the questions that were made, how these concepts will be explored and their relevance

etc., the topic listed as Aims can be incorporated into the introduction as it is presented in a

loose and disconnected way as it is.

<u>Bibliography:</u> There is a topic addressed as a literary reference in the text (it was highlighted

in red with comments in the text) that does not show any connection, not even tangential, with

any point in the work and does not appear to have any relevance to the topic discussed. If the

topic is relevant, it is necessary to incorporate this topic in the text as well, there is no

development at any time that talks about management and/or sports at work and there is no

connection presented between this topic and the topic of distance education presented, if not is

in fact a relevant topic, it is necessary to remove from the work, both the excerpt and the

reference used.

The topic in question: "KUBITSKYI et al. (2022) study the management of pedagogical and

sports, and educational institutions in Ukraine. The authors examine the organizational

structure of pedagogical and sports and education institutions, focusing on the role and

functions of management. They analyze different management models, such as

hierarchical structure, delegation of authority, and collective decision-making."

Methodology: The methodology, despite presenting the methods used, leaves gaps that can be

questioned, starting with the fact that only one of the methods mentioned, scientific research

analysis, is explained in its relevance and connections with the work developed, the others were

just placed as mention without further development, it is important that all cited methods are

developed in their relevance and connection to the work being carried out.

It is also recommended that the methodology contains theoretical references, if possible, of the

methods used, or works by other researchers that attest to the use of such methods for the desired

purposes in the work and in the way it was presented this development is not done in the

methodology, there is, partially, a development of theoretical relevance in literature analysis,

but no mention or connection of this with work done in the field of methodology.

Conclusion: The conclusion is presented very briefly and incompletely, without establishing

any link with what was worked on throughout the text, it is interesting that the conclusions and

proposals presented in the final part of the work are connected with the debates and analyzes

made, this movement beyond to better present the authors' voice, helps readers understand how

the authors used this analysis or that discussion to arrive at that conclusion or question. It can

also be noted that the final paragraphs of the discussion are presented in the form of a

conclusion, and if the authors are interested, they can be incorporated into the conclusion and

developed in this process of improving the conclusion.

References: In the list of references there are several incomplete references, missing

authors' names, it is necessary to change them.
